Linguistic error in phraseology and paremiology

CALL FOR PAPERS

The concept of linguistic error is very broad and challenging to encapsulate into a single definition. For example, a violation of a linguistic norm commonly shared by a community of speakers is considered an error. The same can be said regarding errors as a failure to abide by a school norm. Errors also encompass cases of not adhering to a microcommunity norm, shared by a small group of speakers of any background. Errors can affect both oral and written language. From the perspective of different levels of language analysis, errors can involve spelling, pronunciation, morphosyntax, textuality, translation, and the comprehension and formulation of linguistic acts on a pragmatic level.

The definition and categorization of error(s) also vary depending on the disciplinary approaches used and the areas of application. The concept of error employed in language teaching is not the same as that analyzed in psycholinguistics, patholinguistics, and so on. It is worth noting that in almost all languages, the concept of error is often overlapped with another word used as a synonym (e.g., *errore/sbaglio* in Italian, *erreur/faute* in French, *error/falta* in Spanish, *error/mistake* in English...).

The objective of the 10th International Congress of the *Phrasis* Association is to share the latest developments in the analysis of error within phraseological and paremiological studies. To achieve this goal, proposals addressing errors from various fields and perspectives (linguistics, language teaching, psycholinguistics, neurolinguistics, etc.) are expected. Contributions, whether empirical, theoretical, or methodological, are welcome, including interdisciplinary ones that may help to shed light on the role of errors in the phraseological and paremiological productions of one or more languages.

Presentation can be given in one of the following languages:

→ Proposal submission

Proposals for the presentation of papers or posters can be submitted via the abstract submission form on Phrasis Association's website <http://www.phrasis.it/2024-roma/> by **April 30th, 2024** with the following data:

- Total number of authors
- Name(s) of author(s)
- Author's/authors' e-mail address
- Affiliation (University or Institution)
- Title of paper or poster
- Topic (proposed by the author)
- Abstract including objectives, methodology and a short conclusion (max 2000 characters)
- Keywords (3 to 5)
- Bibliography (max 5 titles)
- Bio (with biographical data, lines of research and two or three recent publications - max. 1000 characters).

Please make sure you press the SEND button once you have filled out the application form. Please be

aware that this is the only procedure to submit a proposal.

It should be noted that the submission of proposals does not constitute an automatic registration to the conference. Registration must be carried out only after having received the notification of acceptance from the Scientific Committee.

→ Notification of acceptance

All submitted abstracts will be evaluated by the Scientific Committee and notification of acceptance will be sent by **May 29th, 2024**.

Presentations will last 30 minutes (20 minutes presentation + 10 minutes discussion). Posters will be displayed during the conference. They must not exceed A0 page size (841×1184 mm).

Further technical instructions regarding paper presentations and posters will be emailed to accepted authors in due time.

→ Publication of contributions

Following the conference, all accepted contributions will undergo a double-blind peer-review process before publication.

→ Registration fees

- **30 May-29 June 2024:** 100 euros for Professors and researchers (70 euros for Phrasis members*); 50 euros for posters, PhD students and Research Fellows.
- **30 June-31 July 2024:** 120 euros for Professors and researchers (90 euros for Phrasis members*); 60 euros for posters, PhD students and Fixed Research Fellows.

N.B.: In case of multi-authored submissions, every author must register and pay the registration fee.

Papers and posters of authors who are not registered by **July 31st, 2024** will not be accepted.
